3. It may be noted that only students who graduate during the validity period of accreditation, will be deemed to have graduated with an NBA accredited degree.

The programs have been granted accreditation for 3 years. **GSSS Institute of Engineering & Technology for Women, KRS Road, Metagalli Industrial Area Mysore- 570 016, Karnataka** should submit the Compliance Report at least six months before the expiry of validity of accreditation mentioned above so as to be eligible for consideration by the concerned Committee in NBA for further processing of the accreditation status.

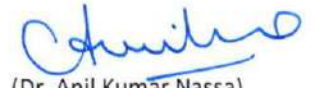
